#### ORDER:

Whereas by virtue of section 3 of the Andhra Pradesh Reorganization Act, 2014 (Central Act No.6 of 2014), the State of Telangana comprising the territories specified therein has been formed on and from the appointed day i.e., of 02.06.2014.

- 2. Whereas, by virtue of section 101 of the Andhra Pradesh Reorganisation Act, 2014 (Central Act No.6 of 2014), the appropriate Government i.e., the State of Telangana is empowered by order, to make such adaptations and modifications of any law (as defined in section 2 (F) of the Act), made before 02.06.2014, whether by way of repeal or amendment as may be necessary or expedient, for the purpose of facilitating the application of such law in the State of Telangana before expiration of two years from 02.06.2014; and thereupon every such law shall have effect subject to the adaptations and modifications so made until altered, repealed or amended by a competent Legislature or other competent authority;
- 3. And whereas, it has become necessary to adapt and modify the Andhra Pradesh Forest Subordinate Service Training Rules, 2012, as amended from time to time, for the purpose of facilitating its application in relation to the State of Telangana;
- 4. Now, therefore, after careful examination, Government have decided to adapt the Andhra Pradesh Forest Subordinate Service Training Rules, 2012, which are in force as on 01.06.2014.
- 5. Accordingly, the following Notification shall be published in an Extra-Ordinary issue of the Telangana State Gazette, dt.01.06.2016.

#### <u>NOTIFICATION</u>

In exercise of the powers conferred by section 101 of the Andhra Pradesh Reorganisation Act, 2014 (Central Act No.6 of 2014), the Government of Telangana hereby makes the following Order, namely:-

- 1. (1) This Order may be called the Andhra Pradesh Forest Subordinate Service Training Rules, 2012 (Telangana Adaptation) Order, 2016.
  - (2) It shall be deemed to have come into force with effect from 02.06.2014.

- 2. The Andhra Pradesh General Clauses Act, 1891 shall apply for the interpretation of this Order as it applies for the interpretation of a State.
- 3. For the purpose of this Order, and the Rules adapted herein, the expression "the State" shall have the meaning and area as specified in section 3 of the Andhra Pradesh Reorganisation Act, 2014.
- 4. In the Andhra Pradesh Forest Subordinate Service Training Rules, 2012, for the expression "Andhra Pradesh" (occurring otherwise than in a citation or description or in title of other enactments), the word "Telangana" shall be substituted.



"The period of training for the Forest Beat Officer shall be 6(six) months and for Direct recruited Forest Section Officers 1(one) year. In case of the Forest Section Officer who are promoted from the category of Forest Beat Officer and who have already undergone six(6) months induction training in that category have to undergo three (3) months Orientation course. The training sessions shall be as follows:

(a) FBO: 1st Batch - From 1st October to 31st March (Six Months)

2<sup>nd</sup> Batch - From 1<sup>st</sup> April to 30<sup>th</sup> Sept. (Six Months)

(b) FSO (DRs / Convertees): From 1st October to 30th Sept."

(c) FSO (Promotee)

: From 1st October to 31st Dec. (Three months)

In the reference 2<sup>nd</sup> read above, the Principal Chief Conservator of Forests, Telangana, Hyderabad has submitted proposals for amendment to Rule 14 of Telangana Forest Subordinate Services Training Rules, 2012. As per the said rules, the period of training for the Forest Beat Officers shall be six (6) months and for Forest Section Officers one (1) year. 

In these circumstances a resolution is taken that qualifying the marks for passing the course which is 40% in each subject will be a difficult task in case of 3 months FSOs (P) training batch which is a standard prescribed for one year course.

Further, the committee has also made a resolution that the question paper to be set for 50% objective type and 50% descriptive type instead of 30% and 70% respectively which is for one year FSO training course

In this regards the committee opined after carefully examination of the situation to fix up qualifying marks for each subject as 30% only.

- Kind attention is invited to the subject cited, the Principal Chief Conservator of Forests (HoFF) approved syllabus for three months course of FSOs (Promotees). The first batch of FSOs (P) started on 3<sup>rd</sup> October, 2017 and would come to a close by 6<sup>th</sup> January, 2018. End course examinations are scheduled from 19<sup>th</sup> December, 2017.
- In this regard, it is to bring to your kind notice that about 50% of the trainees studied only SSC and their ability to write is very poor.
- Also, they have completed 15-20 years of total service. Keeping in view the above facts, the following is suggested:
- An internal committee has gone through the existing exam pattern, marks for each subject and keeping in view the level of the trainees, suggested the following:
- a. TO allot only 50 marks for each theory paper (presently, most subject have marks).
- b. To permit 50% of question to be given in objective type (presently it is 30% only).
- c. To exclude long answer questions and give only short answer questions for the balance 50% in each subject. Trainees have to answer five questions out of eight. Each short answer question to carry five marks only.
- d. As far as practicals are concerned, Forest Survey & Drawing to carry 50 marks and Forest Engineering 25 marks.
- e. The pass mark to be 30 % (presently it is 40%) in each subject.

It is requested that the above suggestions may be approved.
